Financial report by treasurer Sonja Klein indicated a cash on hand balance of \$796.41 as of December 31, 1979; with income to date increasing the cash on hand to \$8,660.13. Motion by Kreeger, seconded by Dietrich, to accept the financial report as read. Motion carried.

Discussion and presentation of a new contract between the Township and OLHSA for continued use of the Township Hall as a nutrition site. Motion by Klein, seconded by Copeland, to accept the contract presented by OLHSA. Motion carried.

Review of cemetery care for the year of 1979; Board in agreement that excellent care had been maintained. Motion by Kreeger, seconded by Klein, to rehire the same caretakers for ensuing year. Motion carried.

Report to the Board that Zoning Board has completed changes in the Zoning Ordinance. A public hearing will be held on February 14, 1980 at the Township Hall. Supervisor urged all members of the Board of Trustees to attend.

Presentation of bills; Motion by Kreeger, seconded by Klein, to pay bills as presented, plus Detroit Edison bill when due. Motion carried.

Trailer permit applications presented. Motion by Kreeger, seconded by Klein, to approve the applications for Accessory Trailer permits of Terry Eisele and Jack Sherwood. Motion carried.

Review by Board of Temporary Trailer Permits. Motion by Kreeger, seconded by Klein, that Clerk notify Arthur J. Richards concerning requirement of a performance bond and of permit fees overdue. Motion carried.

Motion by Kreeger, seconded by Klein, to approve contract for major maintenance on Owosso Road from Chase Lake Road to Sherwood Road, plus 500 feet north of Sherwood Road; contract stated at \$48,000.00, to be shared with Gochoctah Township. Motion carried.

Motion by Kreeger, seconded by Copeland, to pay bills as presented. Motion carried.

Motion by Klein, seconded by Copeland, to adjourn the meeting at 11:25 P.M. Motion carried.

Presentation and discussion of proposed road construction by the Livingston County Road Commission, to be financed by a request of the voters of Livingston County for a three mill tax program for possibly ten years. For Conway Township it would mean about two additional miles of blacktop road. As more time for study was needed, Supervisor called for a Special Meeting for more input from Board members. Meeting to be held Friday March 21, 1980 at 8:00 P.M. at the Township Hall.

The Annual Meeting Of Conway Township was called to order by Supervisor Kingsley with nine people present. Also present was County Commissioner Carolyn Carlsen. Minutes of the 1979 Annual Meeting were read and approved.

Copies of the Financial Report were distributed by Treasurer Sonja Klein. Receipts to the Contingent Fund for the year totaled \$62,379.24 plus transfers of \$11,000.00 from the Federal Revenue Sharing Fund and \$15,639.62 from the Improvement Fund, which made a grand total of \$89,018.86. Disbursements for the year were \$88,018.86 leaving a balance on hand of \$1,000.00. Treasurer reviewed all funds and Supervisor then called for any questions concerning the Financial Report. Motion by George Robb, supported by Gordon Carbary, to accept the Financial Report as read. Motion carried.

Proposed Federal Revenue Sharing Budget hearing conducted by Clerk Dietrich. Funds on hand and disbursements for fiscal 1979-80 reviewed, and the estimated funds for 1980-81 presented. Total estimated funds available were \$5,609.60 with \$5,500.00 proposed for road maintenance. Motion by Doreen Carbary, supported by Gordon Carbary, to accept the Federal Revenue Sharing Budget as presented. Motion carried.

Township budget for 1980-81 presented by Clerk with a request for two mills from the Tax Allocation Board. Discussion road work and Trustee Copeland presented a report on the recreation program; discussion on millage request and the possibility of Tax Allocation being for two years. Motion by George Robb, supported by Gordon Carbary, to accept the budget as presented, to be adjusted according to millage allocated. Motion carried.

Supervisor Kingsley reported on the proposed millage for road construction that would probably be voted on at the August Primary Election. This would be a County wide proposition.

Commissioner Carlsen reported on the future of Federal Revenue Sharing; and that the Community Block Aid Program had been renewed for the County. This is for aid to low income and senior citizens for improvements and renovation.

Motion by Gordon Carbary, supported by George Robb, that regular meetings of the Township Board be held the third Tuesday of each month. Motion carried.

Motion by Anna Dietrich, supported by Doreen Carbary, to deposit the monies of the Township in the Community State Bank of Fowlerville. Motion carried.

Supervisor reported that Bill Barr, Inc. has been approved to spread oil for dust control, the price to be forty cents a foot. Board was in agreement to follow same procedure as in previous years.

Discussion of approval by the County Planning Commission of changes in the Zoning Ordinance. Motion by Dietrich, seconded by Klein, to rescind the motion of February 19, 1980 to wit: motion by Dietrich, seconded by Kreeger, to approve the recommendations of the Zoning Board for changes in the Zoning Ordinance, to take effect within thirty days of publication. Motion to rescind carried.

Motion by Copeland, seconded by Klein, to approve the recommendations of the Zoning Board for amendments to the Conway Township Zoning Ordinance, that have also been approved by the Livingston County Planning Commission, and such changes take effect immediately after publication. Motion carried.

Board agreed to meet with Cohoctah Township Board and with Road Commission to determine what is feasible.

Raymond Bird present requesting approval for an Original Distressed Vehicle Transporter Dealer License Application. The application concerned clarification of zoning status. Discussion of the pole building being constructed by Paul Bauby at 9490 Sherwood Road. Motion by Klein, supported by Kreeger, to notify Paul Bauby that his building is in violation of ARTICLE XII. YARDS of the Conway Township Zoning Ordinance, because the building is less than the required fifteen feet from the property line. Motion carried.
