WHEREAS, the difficult economic times make immediate meaningful relief for the citizenry from the existing property burden absolutely essential; and,

WHEREAS, recent studies conducted by both County and State officials forecast substantial increases in assessed values in 1982 under the existing system; and,

WHEREAS, the Constitution of the State of Michigan empowers the State Legislature to establish a level of equalized value no higher than fifty percent (50%) of true cash value; and,

WHEREAS, the Constitution of the State of Michigan also grants authority to the Legislature to establish a level of equalized value at any point below that fifty (50%) maximum; and,

WHEREAS, the Conway Township Board stands committed to a program of meaningful tax relief;

BE IT, THEREFORE, RESOLVED, that the Conway Township Board does hereby respectfully request that the Legislature of the State of Michigan lower the level of equalized value to forty-five (45%) of true cash value effective in 1983 and henceforth until a more comprehensive tax reform formula is developed.

BE IT FURTHER RESOLVED, that the Conway Township Board supply copies of this resolution to the Legislature, Governor, Livingston County Board of Commissioners and other Townships of Livingston County.
